## **HIGHLIGHTS OF THE PROGRAMME**



### INCEPTION PHASE PLACES A SOLID BASIS FOR PROJECT IMPLEMENTATION

From April - September 2021, the BOMCA implementing team dedicated its primary efforts towards setting up a solid foundation for successful multi-year project implementation. To this end, the project implementing Consortium held a series of consultation meetings with Central Asian national beneficiary agencies and international stakeholders, to streamline the Programme's intervention areas and synergies with other initiatives, as well as to re-establish cooperation and communication channels for the upcoming implementation period. The team of dedicated professionals, both international and national, was assembled and the project offices opened in Central Asian capitals, with the Regional Office seating in Bishkek, Kyrgyzstan. A particular consideration was given to the conceptualisation of the project's visual identity and communication strategy, in order to raise awareness about the project among all target groups. The project has recently launched a dedicated website, multiple social media accounts and a short video, presenting the focus of the 10th phase and its key features.



### WORLD CUSTOMS ORGANISATION GIVES ACCREDITATION TO THE UZBEK CUSTOMS INSTITUTE

In November 2021, the Customs Institute of the State Customs Committee of the Republic of Uzbekistan was awarded with a professional standards recognition certificate of the World Customs Organization (WCO), in accordance with the PICARD Programme (Partnership in Customs Academic Research and Development).



### 1ST MEETING OF BOMCA 10 REGIONAL STEERING GROUP

On December 6 2021, the first meeting of the BOMCA 10 Regional Steering Group, attended by representatives of the project beneficiaries from the Central Asian countries, project Consortium partners and EU Delegation to Kyrgyzstan, was held in Bishkek. The meeting served as a forum for informing about the outcomes of the project's inception phase, providing an overview of the conceptual planning and monitoring, as well as endorsing implementation plans for 2022. General Guntis Pujats, BOMCA 10 Project Coordinator, State Border Guard of the Republic of Latvia, underlined the importance of the meeting for strengthening regional cooperation and mutual support towards delivering sustainable project results.



### OFFICIAL KICK-OFF OF THE PROGRAMME'S 10TH PHASE

December 7, 2021 marked the official launch of the 10th phase of BOMCA Programme at the project Opening Conference in Bishkek, Kyrgyzstan. Aimed at informing BOMCA beneficiaries and stakeholders about the objectives, implementation strategies and expected project results in all five Central Asian countries, the event gathered over 100 participants representing the project implementing Consortium, national authorities, international organisations, EU Member States and EU Delegations to Central Asian countries. In her welcoming address, Ms. Terhi Hakala, EU Special Representative for Central Asia, noted that BOMCA Programme represents the spirit of EU-Central Asian cooperation and is instrumental for ensuring regional security and stability.

The international accreditation of the Uzbek Customs Institute's educational programme strengthens scientific cooperation with academic circles abroad, develops the academic mobility of teachers and students, strengthens the Institute's position in the international education market, including contributing to the Institute's reputation as a center of international customs education programmes in Central Asia.

FEATURED STORIES

The BOMCA Programme actively supported the Uzbek Customs Institute in the process of achieving WCO recognition by analysing existing customs education and training systems and developing recommendations for fine-tuning academic curricula in the key relevant areas to align them with the WCO PICARD professional standards.

Remarkably, the educational programmes of the 13 higher education institutions in just 10 out of the 183 WCO member countries are accredited in accordance with PICARD standards today.

### AFGHANISTAN: RESPONSE TO SECURITY CONCERNS



Recognising political developments in Afghanistan and impact on the Central Asian neighbouring countries, the Programme has prioritised thematic and technical support to national authorities of Tajikistan in addressing pressing needs. Special attention was paid to risk analysis, profiling and identification, document security and initial technical support. It should be however underlined that the main part of procurement of equipment for the beneficiaries will take place at the later stage of the project implementation.

Since the start of its implementation phase in October 2021, BOMCA has concentrated its efforts across all four thematic components and ensured its activities at both national and regional levels.

Recognising the role and work of other international stakeholders in the region, the project has ensured the coordination of activities and cooperation through joint events with various partner organisations and programmes. While various waves of Covid-19 went through the region and quarantine measures did not always allow for meetings of national counterparts on a face-to-face basis, solutions have been found through blended or online formats, so that the activities for all five countries of the region could take place. The speed of implementation has also been steadily increasing and the next period will see even higher number of activities.
